## 2020 Farmers Challenge Regulations

1. These Special Regulations apply to The Nambucca River District Agricultural Association Ltd Farmer Challenge Competition and operate alongside The Nambucca River District Agricultural Association Ltd General Regulations.
2. These Special Regulations shall constitute the whole agreement upon which an entry is submitted and the entrant agrees that all representations and statements not itemized herein are excluded.
3. This competition is open to teams of four people. Teams must contain at least one male or female. Competitors will be required to register as a team of four through an official entry form. One competitor must be nominated as the team captain. Correspondence from The Nambucca River District Agricultural Association Ltd will be sent to the team Captain after the valid entry is received.
4. Competitors must be aged between 13 and 25 years of age on the day of the Competition. Competitors may be required to provide proof of age.
5. Any queries regarding eligibility should be referred to the President or [macksvilleshow@outlook.com](mailto:macksvilleshow@outlook.com)
6. For any team wishing to compete, entries must be submitted by 4pm Wednesday 1<sup>st</sup> May 2019.
7. Teams who wish to compete should complete an entry form in full in order to be accepted into the Competition. Invalid entry forms for this competition may not be accepted. The Nambucca River District Agricultural Association Ltd accepts no responsibility for any incorrect or invalid information, or any lost entries as a result of lost data or electronic failure.
8. Competitors will be provided with an information pack before the start of the Competition. The information pack should contain all the information competitors will require to take part in the Competition.
9. All team members will be required to complete and return an Indemnity & Waiver form, as issued by The Nambucca River District Agricultural Association Ltd. Failure to do so may render that team member ineligible to participate in the Competition.
10. Teams will be required to take part in one of The Nambucca River District Agricultural Association Ltd Farmer Challenge Heats Saturday 3rd May 2019. The winning team from each of the heats may progress to the Grand Final, which will be held at the completion of the heats.
11. Prizes awarded pursuant to the Competition are not transferable. Prize money for the Young Farmer Challenge will be presented to the winners at the completion of the Grand Final or within a month post Competition.
12. The Nambucca River District Agricultural Association Ltd adheres to the National Principles as specified in the Privacy Act (Cth) 1988. It has put in place policies and procedures to ensure adherence to this legislation. The information provided by you is used by The Nambucca River District Agricultural Association Ltd to organise, process and conduct Competitions. By entering such Competitions, you consent to your personal information being used for this purpose including this information being made available to sponsors, the media, the public, promotional purposes, archival purposes, published in The Nambucca River District Agricultural Association Ltd publications and could be made available to other third parties for the purpose of promoting The Nambucca River District Agricultural Association Ltd, or as otherwise required by law. The details of each team will be handled in accordance with The Nambucca River District Agricultural Association Ltd Privacy Policy, available from the Show Society office. You have a right of access to and alteration of personal information concerning yourself in terms of the Privacy Act. This may be done by contacting the coordinator of the Competition or The Nambucca River District Agricultural Association Ltd Secretary.

In consideration of The Nambucca River District Agricultural Association Ltd accepting this entry, the entrant indemnifies The Nambucca River District Agricultural Association Ltd, judges, officials, stewards or any sponsor or provider of prizes against all claims, losses, suits and demands made against or suffered by The Nambucca River District Agricultural Association Ltd by reason of any act of omission on the part of the entrant and that the entrant agrees that any act or omission on his/her part found in any action against The Nambucca River District Agricultural Association Ltd to be negligent shall be deemed to have been a claim under this indemnity.

14. The entrant must disclose any medical condition reasonably expected to restrict tasks to be undertaken during The Nambucca River District Agricultural Association Ltd Farmer Challenge to the coordinator of the Competition. Such disclosure to The Nambucca River District Agricultural Association Ltd will also adhere to the Privacy Act (Cth) 1988 legislation, as referred to above. 16. The winner is final and no further correspondence will be entered into by The Nambucca River District Agricultural Association Ltd.

17. A competitor only may enter a protest against any decision or act or omission on the part of - a judge; The Nambucca River District Agricultural Association Ltd; or any official of The Nambucca River District Agricultural Association Ltd.

18. The Nambucca River District Agricultural Association Ltd has the discretion to terminate, retract or change any aspect of the Competition during the period.

19. It is highly recommended that Teams be familiar with these Special Regulations. Upon submitting their entry form, all members of the team agree to adhere to all the provisions as set out in these Conditions. All members of the team further acknowledge that the Special Regulations are subject to change.
